

My Market Contest Terms & Conditions

The My Market Contest (“Contest”) is organised by Bursa Malaysia Berhad (“Bursa Malaysia”) and Creador Foundation (collectively “The Organiser”). By participating in this Contest, the participants agree to be bound by the My Market Contest guide and the terms and conditions stated herein (“Terms and Conditions”).

Contest Period

The Contest will run from 4 May 2021 until 4 July 2021 (“Contest Period”).

Eligibility

This Contest is open to all Malaysian citizens residing in Malaysia excluding employees of the Organiser, the respective subsidiaries, advertising and promotion agencies, and suppliers, and immediate family members. Eligible persons who participate in the Contest must be 18 years of age and above as at the date of participation in the Contest (“Participants”).

Contest Mechanics and Selection of Winners

- a) To participate in the Contest, Participants are required to have a registered account with Bursa Marketplace at www.bursamarketplace.com (“Bursa Marketplace”). Information submitted during registration is subject to the Personal Data Notice on Bursa Marketplace. To read the Personal Data Notice, click [here](#).
- b) There are two (2) categories of Participants in the Contest as follows:
 - (a) New Users which consist of Participants whose Bursa Marketplace accounts are registered on or after the start date of the Contest; and
 - (b) Existing Users which consist of Participants whose Bursa Marketplace accounts are registered before the start of the Contest.
- c) All Participants are required to complete all four quests under the Contest as follows:
 - Use the Screener Tool to search for stock(s) that are priced under RM1
 - Select a stock and add it to your My Market Contest Watchlist
 - Use the RM20,000 virtual money to select a stock, place it in your My Market portfolio and buy it
 - Make a profit of at 5% in your My Market Contest portfolio within the Contest Period
- d) The first 21 Participants in each category (i.e. New Users and Existing Users) to complete all 4 quests will win a prize (“Winners”).
- e) Each Winner can only win 1 prize (as detailed below) throughout the Contest.
- f) In the event of a tie, the Participant having the highest gain of profit at the end of the Contest Period will be determined as the Winner.
- g) Announcement of Winners will be made within a month from the last day of the Contest Period. Winners will be notified via their email address registered with Bursa Marketplace and are required to submit a softcopy of their identification card, full name, telephone number and mailing address and any other information required by the Organiser for verification within 7

days from the date of the e-mail notification. The Organiser reserves the right to disqualify the Winner and select another Winner in the following circumstances:

- i) any discrepancy between the details registered in Bursa Marketplace and the details provided by the Winner for verification;
 - ii) the Winner does not meet the eligibility criteria; or
 - iii) the Winner does not respond to the e-mail notification within abovementioned time period of 7 days.
- h) The Organiser shall not be held responsible or liable for any late, misdirected, lost or unsuccessful efforts to notify the Winners. The Organiser shall have no liability for any Winner's failure to receive notices due to spam, junk e-mail or other security settings, email services or interruption in the internet connection etc.
- i) All decisions relating to Winners are final and binding and no further correspondence relating to the same shall be entertained.

Prizes

Participant's Conduct

The Organiser reserves the right at its sole discretion to disqualify any Participant that is suspected of or that it determines to be tampering with the entry process or the participation in or operation of the Contest or to be acting in breach or potential breach of the Terms and Conditions.

- a) The Organiser (including its respective employees, officers, directors, affiliates, and subsidiaries) shall not be liable or responsible for damages, losses, injuries, rights, claims or actions of any kind in connection with the Contest, or resulting from participation in the Contest and/or acceptance, possession, use/misuse of prizes.
- b) In no event shall The Organiser or any of its respective officers, servants, employees, directors, affiliates and subsidiaries, representatives and/or agents (including without limitation, any third party service providers engaged by The Organiser for purposes of the Contest) be liable to Participants in this Contest for any direct, indirect, special or consequential loss or damage arising from or in connection with the Contest.
