

“FM70 Quiz Challenge” Terms and Conditions

1. The “FM70 Quiz Challenge” (“Challenge”) organized by Bursa Malaysia Derivatives (“BMD” or “Organizer”) will commence on 1st September 2022 and end on 31st December 2022, both dates inclusive (“Challenge Period”).
2. This Challenge is aimed at generating interest in the Mini FTSE Bursa Malaysia Mid 70 Index Futures (“FM70”) contract.
3. Throughout the Challenge Period, eight (8) rounds of quizzes (“Quiz Round”) will be held as follows:

Quiz Round

- 1st round: Week 1 of September 2022
- 2nd round: Week 3 of September 2022
- 3rd round: Week 1 of October 2022
- 4th round: Week 3 of October 2022
- 5th round: Week 2 of November 2022
- 6th round: Week 4 of November 2022
- 7th round: Week 2 of December 2022
- 8th round: Week 4 of December 2022

4. **Eligibility**

This Challenge is open to all residents of Malaysia. Eligible persons who participate in the Challenge must be 18 years of age and above as at the date of participation in the Challenge (“Eligible Participants”).

5. **Challenge Mechanics**

- 5.1. The Challenge will be carried out on all Bursa Malaysia social media platforms which include Facebook, Instagram and Twitter.
- 5.2. Eligible Participants shall be considered as participating in the Challenge when their answers and personal details are submitted to the Organiser via the Google Form which will be made available on Bursa Malaysia’s social media platforms. To qualify to win a prize, Eligible Participants are required to answer the quiz questions correctly.
- 5.3. Multiple entries from any social media platform in each Quiz Round will be counted as one entry.

6. **Winner Selection and prizes**

- 6.1. Winners of the Challenge will each receive a Touch ‘n Go eWallet Reload PIN worth RM 100.
- 6.2. A total of twenty-four (24) winners for the Challenge will be selected with three (3) winners for each Quiz Round.

- 6.3. Eligible Participants will be ranked chronologically based on their submission time in each Quiz Round and the first three (3) Eligible Participants to submit correct answers will win a prize.
- 6.4. Eligible Participants who have submitted incorrect answer(s) will not qualify to win a prize.
- 6.5. Each Eligible Participant shall only be entitled to win one (1) Prize throughout the Challenge. The Prize is strictly non-transferable to any third party, non-negotiable, non-exchangeable and cannot be used in conjunction with any other offers or promotions.
- 6.6. The Organiser reserves the right to substitute the Rewards with that of equivalent or similar value at any time without prior notice.
- 6.7. If any winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited, and BMD shall be entitled to select another winner.
- 6.8. BMD will not be held liable or responsible for any late, misdirected, lost or unsuccessful efforts to notify the winners or to issue the prizes. - 7.1. Winners of the Challenge will be notified via email within fourteen (14) working days from the end of each Quiz Round.
- 7.2. The Organiser's decision is final and binding.
- 7.3. All winners are required to respond within **five (5) working days** from the notification date, failing which, the prize will be forfeited to the next eligible winner. BMD shall not be liable for any losses, expenses, claims and demands for such forfeiture.
