

#WhatsYourInterest Sweepstakes Terms & Conditions

The #WhatsYourInterest Sweepstakes (“Sweepstakes”) is organised by Bursa Malaysia Berhad (“Bursa Malaysia”). By participating in this Sweepstakes, the participants agree to be bound by the Sweepstakes terms and conditions stated herein (“Terms and Conditions”).

Sweepstakes Period

The Sweepstakes will run from 12th November 2021 until 31st December 2021 (“Sweepstakes Period”). The Sweepstakes comprise of multiple mini sweepstakes that will run for periods of 3 to 5 days within the Sweepstakes Period.

Eligibility

This Sweepstakes is open to all Malaysian citizens residing in Malaysia who are 18 years of age and above as at the date of participation in the Sweepstakes.

The following persons are not eligible to participate in the Sweepstakes:

- (a) Sweepstakes managers and their immediate family members; and
- (b) Advertising and promotion agencies and suppliers of Bursa Malaysia related to the Sweepstakes, and their respective immediate family members.

Participation in Sweepstakes

Eligible persons who participate in the Sweepstakes (“Participants”) are required to answer Sweepstakes question(s) on the respective Sweepstakes post on any or all of Bursa Malaysia’s BursaMKTPLC social media platforms i.e. Facebook, Twitter and Instagram (“Social Media Platforms”).

Participants from each Social Media Platform (i.e. Facebook, Twitter and Instagram) who “Like” or “Follow” a BursaMKTPLC social media page and submit the correct answer(s) to the Sweepstakes question(s) will be eligible to win a prize.

Participants who participate in the Sweepstakes on any or all of the Social Media Platforms and who are eligible to win are only entitled to win one prize per mini Sweepstakes throughout the Sweepstakes Period.

Prizes

Winners will each be awarded with a RM50 e-gift voucher (“Prize”). Prizes are given on an “as is” basis, are not transferable and are not exchangeable for cash or other items in kind. Bursa Malaysia reserves the right to substitute the Prize with that of equivalent or similar value at any time without prior notice.

Selection and announcement of Winners

30 winners (10 winners from each Social Media Platform) will be selected by a randomizer (“Winners”) per mini sweepstakes. Announcement of Winners will be made within 14 days from the last day of the mini Sweepstakes Period. Winners will be notified via a Winners announcement post on each of the Social Media Platforms.

The Winners must respond and provide their personal details as required by Bursa Malaysia within seven (7) working days upon the announcement of the Winners. Winners are personally responsible for ensuring that their personal details have been accurately submitted. If a Winner fails to provide correct information or does not respond within 7 working days period from announcement of Winners, his/her entry will be disqualified and the Prize shall be forfeited by Bursa Malaysia.

Bursa Malaysia reserves the right to disqualify the Winner and forfeit a Prize and select another Winner if a Winner does not meet the eligibility criteria. If a Winner is disqualified and the Prize forfeited, Bursa Malaysia may, at its sole discretion, select another Winner from the remaining eligible entries (“Replacement Winner”).

Any Replacement Winner(s) will be tagged in a separate Winners announcement in the comment section of the Sweepstakes post. Replacement Winner(s) must respond and provide their personal details as required by Bursa Malaysia within five (5) business days upon announcement of the Replacement Winner(s). If a Replacement Winner(s) does not respond within the stipulated period and provide personal details as required by Bursa Malaysia, the Prize shall be forfeited by Bursa Malaysia and there will be no further winner replacement at this point.

Bursa Malaysia shall not be held responsible or liable for any late, misdirected, lost or unsuccessful efforts to notify the Winners.

All decisions relating to Winners are final and binding and no further correspondence relating to the same shall be entertained.

Prize Distribution

Bursa Malaysia will distribute the prize to the Winners within 30 working days from receipt of confirmation of Winners' personal details.

Bursa Malaysia expressly disclaims any and all liabilities arising from any loss, damage or unsuccessful delivery of the Prize.

Participant's Conduct

Bursa Malaysia reserves the right at its sole discretion to disqualify any Participant that is suspected of or that it determines to be tampering with the entry process or the participation in or operation of the Sweepstakes or to be acting in breach or potential breach of these Terms and Conditions.
